The Puppy Warranty handout refers to kennel cough as a common ailment of dogs. Puppies showing any symptoms of kennel cough while in the care of Pet World are treated for the ailment and disclosure provided to the purchaser. Section 357 of Article 26 of NYS Ag & Mkts Law was discussed. This section of law refers to those persons who willingly sell or offer to sell animals that have contagious or infectious diseases that are dangerous to other animals. Kennel cough is not usually a dangerous disease although it is contagious.
