*Open windows were used for natural ventilation in the room housing puppies in cages. Fecal/urine odors detected upon initial inspection dissipated when a ceiling vent was turned on in the room. A portable fan was available but not in use. Section 401.1.c of Article 26-A requires adequate ventilation at all times. It is recommended that the windows, vent and fan be more consistently and properly utilized to eliminate odors by facilitating air transfer while minimizing drafts. Also, the addition of absorbent materials such as newspaper or wood shavings to the catch pans under the wire flooring of the cages would help alleviate odors.*
