Per law, the license renewal application must be received in Albany 30 days prior to the expiration date of the license. The expiration of the license is 6/26/15. The license renewal was received in the Albany office on 5/28/15. The envelope was postmarked 5/26/15 which was the date the renewal was due. In future, please remit the renewal application so it will be received in the Albany office BEFORE 30 days elapse or it will be considered "late".

Labs of Love has a boarding facility that was recently opened at a separate premises. Dogs no longer used for breeding will be housed at the site. Puppies and breeding dogs will also be housed there on occasion. Those puppies will be 7 weeks of age and already promised to new owners. None of the dogs will be offered for sale while at the boarding facility. Since the boarding facility is an off-site housing area and the public will be allowed to view dogs that are part of the breeding business, it will be subject to inspection under Pet Dealer Law. As part of the Vet Plan, It is expected that the veterinarian will also visit the boarding facility annually.

An unscheduled inspection of the boarding facility was conducted on 6/18/15 at 2:00 pm. All was found to be in compliance with Pet Dealer Law.

The veterinarian visited the breeding premises on 6/23/15 and the boarding facility on 7/7/15.
