- 11/16/15 is the recorded acquisition date on the standard form. Other inspected records show the acquisition date as 10/27/15.

- The USDA individual identifying number entered on the standard form is 2515. Other inspected records show the number as 2919.

- Section (e) of the standard form has a record of a "2nd shot" given to the puppy on "12/11". The type of vaccine administered was not recorded.

- Section (e) of the standard form was used to record administration of an antibiotic. Section (g) of the form is the appropriate section to record any veterinary treatment or medication received by the puppy while in the possession of the pet dealer.

- The standard form did not include the veterinary finding of a small umbilical hernia that was recorded on the health certificate.
