NO SIGNS OF ILLNESS OR DEFORMITY WERE OBSERVED.

A cocker spaniel puppy and a Havanese puppy each had some tear stains on the fur beneath their eyes. Close examination found the eyes clear and dry in both puppies. The kennel room was recently cleaned and odors were at a minimum but proper dilution for bleach was discussed as its fumes can irritate the eyes.

The Havanese puppy and two Boston-Pom mix puppies were observed moving freely and normally on the floor. One of the Boston-Pom pups was shy at first and did crouch and curl up but then romped and played in a normal manner.

No medical treatment records were on file for the current puppies or those sold in the past month. The manager, Ms. Kloc, said no puppies have exhibited signs of illness. All health certificates generated on these puppies note they were healthy and fit for sale at the time of examination.
