Multiple primary enclosures had a mixture of fresh sawdust and soiled newspaper shreds. Excessive debris in exercise yard poses risk of injury and/or disease to animals. Room where puppies were allowed to roam free when shown to potential buyers had large amount of moving boxes and personal items making it easy for puppies to become lost and/or injured.
