The Pet dealers report that they applied to the Town Clerk for 14 dog licenses and provided rabies vaccination certificates and payment for the licenses, but upon inspection, it appears that the Town Clerk was unable to properly process their applications.
Instead of licenses, the Clerk provided them with 14 town receipt forms and 14 dog license tags. These receipts contain no title or reference to dog license, no dog name or description, no rabies vaccination information and no expiration date. The Clerk hand-wrote dog names on a few of the receipts, but most are not labeled, so it cannot be determined to which dog they were assigned.
