Previous deficiencies noted on 9/26/2019 inspection have been corrected.

Drains that are present in two of the four outdoor runs in the male/stud kennels are slow to drain and are getting clogged with leaves.

Dirt in surrounding pen area of outdoor male/stud kennels has been saturated with feces and urine from cleaning out kennels. The odor was very strong and alternative methods of cleaning the area must be explored.

Dogs that were present in the affected kennel area appear to be healthy and were not covered in fecal material.
