*The wire gates of two adjoining outdoor exercise pens have sections that been damaged by the dogs pulling the wires away from the frame so that there are areas where a dog could get caught, cut, or otherwise injured by the sharp ends of the wires sticking out.*

2. Surfaces **General**

*There are small sections on the metal dividing walls of the indoor portion of two of the indoor/outdoor kennels where thick layers of loose old paint were not not scraped off prior to very recent repainting that trap debris and are starting to flake off and so cannot be properly sanitized.*

*Also, the bottom surface of the liner of the doggie door portal in one of the indoor/outdoor kennels has been damaged and partially torn away by the dogs, exposing openings where debris falls in and cannot readily be removed or properly sanitized.*
