**REMARKS:**

Arrived at new facility 329 Church Rd, Hudson at 10:15am. I knocked loudly on the front door and looked down the row of outside kennels on either side of the building; dogs were present in some of the outdoor kennels on each side and there was barking from inside, but no person appeared.

I contacted Mr. Rist by phone, 518-821-0762. He stated that he was en route to NYC with his wife and wouldn't be available until the next day or next week. He stated that he had someone coming to care for the dogs in 1/2 hour. I asked if that person could accompany me for an inspection of the facility. He said no, that the person had not been authorized to allow others in the building. I then asked if he could contact the person and give authorization by phone. He said no, he had called the person earlier in the morning at home and did not have a cell phone number for the person.

As I stood on the front sidewalk and looked down each side of the building, I observed that an excessive amount of feces & urine were present in the first outdoor kennel on each side and that the dogs contained within were coated with waste. I left the premises and returned at 11:45am and again found no person present and conditions in those kennels were the same-no cleaning had been done.

As no one was present, I did not proceed any further and this inspection report is based solely upon my observation of the conditions within those two kennels at the time of my visits.
