As European import requirements include rabies vaccination and a 3 week post-vaccination waiting period prior to shipment, Dr. Chico has approved a delay in the health exam requirement to 12 weeks of age, provided that adequate documentation is maintained. This will allow for rabies vaccination and health exam at 12 weeks with a one week window for shipment before the certificate of veterinary inspection (health certificate) expires.*
