**Inoculations:** According to Article 26A, 401.5(b), "All animals shall be inoculated as required by state or local law." NYS PH Law requires all dogs to be vaccinated by 4 months of age. Rabies vaccinations need to be kept current for all of your dogs and provided for review at the time of inspection.

**Health Exam/CVI:** All intact dogs need an annual veterinary exam and a supporting health certificate must be provided at the time of inspection for each dog.

**Breeder stated no puppies were sold in the past year. When asked to provide information for the puppy packets provided to the consumer, the prepared packets did not have the following which must be provided to the consumer and was unable to produce the documents. These documents were provided at the time of inspection:**

Rabies information sheet (NYS Department of Health)

"The Sale of Dogs and Cats" consumer rights notice (Article 35D, Sec. 754)

Information on the value of spaying and neutering (Article 35D, Sec. 753-b, 3)

Dog licensing notice (Article 35D, Sec. 753-b, 2f).

Disclosure of Animal Pedigree Registration (Article 35D, Section 753-c, 3b)
