## REMARKS:

Kathy Smith, Animal Control Officer & Donald E. Draper, Jr., Undersheriff, also present for inspection.

Must have a complete record of the disposition of each dog seizure. Dispositions of the dogs seized were incomplete. According to Article 7 Section 113.4 and 113.5, all records must be complete and include the complete disposition (what happened to the dog). When a dog is redeemed by the owner (returned to the owner,) according to Article 7 section 117.4, 117.6, and 117.9 the dog must be licensed before released or show proof that it was licensed by documenting this in the records. The name of the person/clerk/town who issued the license and the date the dog was redeemed.

Records must be complete at the time of inspection. This is often accomplished by communication between the municipal offices, the contracted shelter and the DCO. According to Article 7 section 117.4 Dog Control, municipal shelters and municipalities may not waive Impoundment fees or charge less than the statutory rates for impoundment fees unless a local ordinance has been written. For dogs which are seized (picked up) for Article 7 reasons, a disposition report must be filled out and an impoundment fee collected before returning the dog to the owner. All impoundment fees collected must be recorded with the disposition reports in order to determine this at the time of inspection. The shelter cannot release an "Article 7" dog unless the owner shows proof of current license, identification and proof that the impoundment fee has been paid. According to Article 7 Section 113.4 and 113.5, all records must reflect this information has been verified and be included in the disposition report. For dogs not redeemed by owner, the disposition record must be completed with the outcome of the dog, such as adoption or transfer information.

There was a mother dog and litter of puppies about two weeks of age at the the shelter. They were housed in a kennel with a concrete floor and a towel for bedding. Alternate housing was discussed. Per the NYS DCO Shelter Guideline, page 9: "A whelping box must be provided for pregnant and/or nursing dogs with puppies. It should encourage the bitch to remain in the box to care for her puppies, yet allow her to exit at will. The box should keep the pups contained. It must be constructed in such a way to prevent injuries and to allow for adequate cleaning. If made of wood, it must be sealed or lined with an impervious material that can be readily sanitized. "Pig rails" must be installed, if needed, to protect the puppies from being crushed and to prevent them from climbing out of the box. PVC pipe works well for this purpose." A complete document of this has been emailed to the parties present at the inspection.

Shelter repairs/maintenance were also discussed. Repairs are needed to bring the shelter to compliance to current standards. Maintenance requests have have been submitted several months ago without response from the maintenance department.

Article 26-C standards were discussed, along with resources for a shelter evaluation to determine what updates would need to be completed to bring the shelter into compliance for the new law for December 2025. These resources were emailed to the parties present at the inspection.
