Staff has prepared a work order request for the county building maintenance department regarding the following repairs:

In the adoptable dog housing area, there are vertical metal posts that dog kennel entry gates are attached to that are secured into the flooring with cement like material applied in a circular pattern. Some of these posts have circular depressions at the base where the material has broken away exposing screw heads. Liquids were contained in the depressions. Dogs may have contact with the screws when entering and exiting the dog kennel which may cause injuries. Liquids should not be allowed to build up or sit for long periods of time. Dog runs in this condition that pose a risk of injury will not be used until repairs have been made. Liquids should not be allowed to accumulate in the depressions.

Two dog runs in the stray dog housing area had broken metal clamps that secured chain link to a metal horizontal pole at the base of the kennel entry gates. The clamps had exposed sharp metal points. The clamps need to be replaced. No dogs will be housed in the kennels until repairs are made.

Some seams in the concrete kennel flooring have lost caulking material.

The facility has an adequate number of kennels that are in good repair.
