## REMARKS:

TITLE: ACO

The mason blocks which make up the walls of the kennels in the housing area are porous and not sealed. There are large chunks of mortar missing between cinder blocks, which leaves large gaps, cracks and crevices. Due to this condition the kennel walls where dogs are housed are not be able to be sanitized properly. Bare concrete and mason blocks require routine maintenance and repairs to allow proper cleaning and disinfection and maintain the structure of the kennels. It is recommended that some sort of permanent sealant is applied to prevent further water and structural damage and allow for thorough sanitation.

All enclosures housing seized dogs must be structurally sound and kept in good repair to keep the dog contained and to protect it from injury. There must be no rust, jagged edges or sharp points. Damaged areas of kennels must be repaired or replaced to prevent dogs from ingesting any materials that may come loose from chewing and clawing the enclosure. Wood must be sealed if it is used for walls. Due to its porosity, concrete must be treated with a liquid sealer or hardener to make it waterproof. Waterproofing prevents water damage to concrete and allows thorough sanitation.
