All surfaces within the primary enclosure must be replaced or repaired when worn or damaged. Dirty, rough and absorbent materials, protect microorganisms and are difficult to clean, disinfect and deodorize. Repair or replace damaged sections to prevent dogs from ingesting any materials that may come loose from chewing and clawing the enclosure. Wood must be sealed if used in primary enclosure to allow for proper cleaning and sanitization.
