There were three dogs that were redeemed that were not licensed because they were too young for rabies vaccinations. I explained that the dogs still need to be licensed before release and a follow-up call is necessary to make sure the pups got the rabies vaccination at 12 weeks of age.

REMARKS:

The shelter is in excellent condition. There are empty runs in which to place newly seized dogs. There were three redeemed puppies that left the shelter without a license because they were "too young" to get rabies vaccinations. I explained that all redeemed dogs must be licensed even if they are too young to be vaccinated for rabies. It is the responsibility of the shelter to follow up to make sure the rabies vaccinations were given once the minimum age for vaccination had been reached. This was done as requested and verified with a visit to the shelter a week later.
