Records consist of a Seizure and Disposition Report that records, in pen, a shelter control number, a description of the dog, the license number of the dog if identified, the date and time of seizure, the location where seized, why the dog was seized and by whom. The owner's name and address is recorded if the dog is identified. Also recorded on this report is the redemption fee payment, the license of the dog if redeemed, who and when it was redeemed, adopted or transferred to or the date of euthanasia and who euthanized the dog. There is also a Shelter Log that records, in pencil, some of the information that is on the Seizure and Disposition report. There is also a computer Microsoft Access program that tracks all of the seizure and disposition information.

The euthanasia of sick or injured dogs was discussed. Section 117.7 of Article 7 and Section 374 of Article 26 provides that if recommended by a veterinarian, in writing, an unidentified seized dog may be humanely euthanized without delay to eliminate any suffering. Computer records of dogs euthanized in 2009 until the present were reviewed. Dogs #061 seized 5/16/10, #178 seized 9/25/11 and #191 seized 10/15/11 were euthanized by York Animal Hospital the

Dog #082 seized 5/1/11 was euthanized 5/5/11 due to an illness that

This inspection is marked satisfactory regarding the holding of dogs for the redemption period as it is based on the records of dogs seized since the previous inspection. However, Section 117.4 of Article 7 regarding the five day redemption period was discussed as two unidentified dogs in past years were euthanized prior to the end of the redemption period. Euthanasia records for dog #055 seized 4/24/09 and euthanized 4/29/09 and for dog #073 seized 6/1/10 and euthanized 6/6/10 show both dogs were euthanized on the fifth day of the redemption period. Per the DCO and Municipal Shelter Guide issued by Ag & Mkts, five days is defined as five 24 hour periods from midnight to midnight. If the shelter is closed the last day of the redemption period, the redemption period is extended one more day.

At the time of inspection, there was an unidentified hound mix in the shelter. DCO Davis searched computer records for a hound mix seized in November of 2011 and known as Mr. Bojangles. She phoned the owner listed on the computer record who told her that some time ago he gave Mr. Bojangles away to his brother who lives in Wayland but the dog ran away from his brother. DCO Davis described the unidentified hound mix to the person who told her he did not believe that dog to be Mr. Bojangles.

The housing of dogs was discussed. Per the DCO and Municipal Shelter Guide, it is recommended that incompatible dogs, females in heat, vicious dogs, and dogs that are ill should not be housed together. Adult dogs, other than the nursing dam, should not be housed with puppies. The manual also recommends that dry bedding or resting boards be provided to dogs housed on damp floors or unheated concrete or stone. At the time of inspection, dogs outside in dog runs were housed individually and blankets provided.

Section 353-b of Article 26 regarding the appropriate shelter for dogs left outdoors was discussed. Any person who has control or custody of a dog that is left outdoors shall provide it with appropriate shelter according to its breed, physical condition and the climate. "Dogs Left Outdoors" is defined in the law as dogs that are outdoors in inclement weather without ready access to shelter. Shelter may be a building or other structure with a waterproof roof, appropriate insulation and room enough to make normal postural movements. Section 353-b.3(a) requires shade be provided to dogs that are restrained outdoors to protect them from direct sunlight that is likely to threaten the health of the dog. The shelter has a gravel exercise area attached to the east side of the shelter that is exposed to morning sunlight. A dog run area on the south side of the shelter constructed of wire enclosures secured to concrete flooring receives sunlight the majority of the day but is protected by a roof overhang. All of the factors discussed should be taken in consideration when leaving dogs outdoors in these areas. Section 371 of Article 26 provides for enforcement of violations by a constable, police officer or any agent or officer of any duly incorporated society for the prevention of cruelty to animals.
