Per kennel staff, the wall partitions of the dog runs that are constructed of cinder block had been cleaned at approximately 10:30 am. At the time of inspection at 2:00 pm they were still damp. The cinder block had absorbed the cleaning fluids. A spray of water on a dry area of the block was immediately absorbed. Concrete is a porous material and must be treated with a liquid sealer or hardener to make it waterproof. Waterproofing is recommended as it will prevent water damage to the cinder block and allow for thorough sanitation.

3. Repairs are done when necessary
4. Dogs are handled safely
5. Adequate space is available for all dogs
6. Light is sufficient for observation
7. Ventilation is adequate

At the 2:00 pm inspection of the kennel areas, dog runs with wall partitions of cinder block were damp in most areas as the block had absorbed cleaning liquids that were applied at 10:30 am per kennel staff. The weather on the day of inspection was cloudy with temperatures in the 50's. Although adequate ventilation and an overhead radiant heat system are available, the lack of sealant on the cinder block surfaces hinders the evaporation of moisture and lengthens drying time.
