## REMARKS:

The kennel is completely full. Thirteen dogs were taken in on 10/18/12 as a result of a seizure in Fillmore in Allegany County. This town does not normally contract with this shelter but asked for help when over 60 dogs were seized from a hoarder.

Dogs and cats are housed in the same room.

The shelter is overcrowded at this time. There are concerns for animal well-being and health parameters because of the number of animals presently housed in the shelter. It is recommended that the shelter population be decreased to a sustainable number which will provide a healthier environment.

Please note that Article 7 Section 109.1 requires all dogs four months of age and older to be licensed. This requirement applies to dogs that are harbored in foster homes.
