**REMARKS:**

The shelter still needs some repairs to the indoor kennel doors, but otherwise it looks in good shape. There is a new outdoor exercise area in which to put the dogs while their kennels are being cleaned. The large mounds of sand/salt were moved this past winter to make the kennel more accessible.

It is recommended that the repairs be done to the indoor kennel doors as soon as possible. It is likely the condition of the doors will continue to deteriorate over time unless they are replaced.
