1. Shelter is structurally sound

2. Housing area and equipment is sanitized regularly

Kennels are cleaned once daily. At the time of inspection, one section of kennel area had not been cleaned and dogs were locked out in runs unable to avoid walking through their own wastes. Concern that shelter not being cleaned frequently enough to remove disease hazards, pest infestation, or odors.

3. Repairs are done when necessary
4. Dogs are handled safely
5. Adequate space is available for all dogs
6. Light is sufficient for observation

One redbone Coonhound exhibiting diarrhea. Staff member informed inspectors due to dietary indiscretion. But no record of veterinary care given to give comfort to intestinal upset.

Many seizure records lack impound fees recorded, number of days impounded, or dates of seizure, redemption or transfer.

Several Town of Montgomery dogs show transfer dates prior to redemption period expiring.

15. Redemption period is observed before adoption, euthanasia or transfer

Several records show transfer prior to redemption period. One record shows redemption to HVSPCA without license or impound paid.

16. Owners of identified dogs are properly notified

Yes

Shelter manager unaware of additional time for notified owners to redeem dogs. 2 seizures show owners notified and dogs transferred after standard holding.

17. Redeemed dogs are licensed before release

18. Proper impoundment fees paid before dogs are released

No record of impound fees paid on most seizure reports on file. Staff member Lisa informed inspectors that shelter collects impound fees for most towns contracted. No record of town impound fees on file. Shelter waives said impound fees without authorization of town clerk. Shelter also collecting license applications for Town of Montgomery and redeeming dogs without collecting impound fees.
