The outdoor dog runs on the concrete pad atop the small hill directly behind the main kennel building have run doors where the vertical pipe on the inside of the door, the edge the door latch is on, has an area approximately two feet in length at dog level where the pipe is hollowed out from rusting through. This area of the pipe contain an opening where dog's toes could become lodged or the dogs could be injured on the sharp edges.
