All kennel sections, which are in the middle of repairs, are housing dogs. Many cages are not in use, and in need of extensive repair. Ten kennels have rusted, jagged edges on the lower framework of the doors. Several kennel frames require painting, repair of rusted, sharp edges or replacement. At least 8 kennel supports have rusted away entirely. Ceiling is missing entirely due to partial reconstruction. Insulation has fallen into the kennels within reach of the dogs. Employees of the shelter mentioned that there are areas of the roof that is leaking into the kennels and the rest of the building.
