All kennel sections housing dogs are in the middle of repairs. Many cages are not in use and are in need of repair. Some kennel supports have rusted away entirely. Half of the kennels require painting, repair of rusted, sharp edges or replacement.

There are at least four more kennel doors that require painting or replacement.

Ceiling above the kennels is missing entirely due to partial reconstruction.

Outside Kennel Runs: South side: From front of building: 5th, 6th and 9th kennels have concrete crumbling with large holes that should be cleaned and patched.

North Side: 3rd & 5th from the back side of the building have concrete crumbling with large holes that should be cleaned and patched. There are several rusted doors that should be replaced on these runs.
