One South kennel section entirely empty of dogs, currently in roof repairs. There are about 6 kennels that still require new inside kennel doors. Some kennel partitions still require some painting and repair of sharp edges. Ceiling above the kennels is missing entirely due to partial reconstruction.

Outside kennel runs on the North side have some doors replaced, but no concrete has been patched or cleaned. North Side: 3rd & 5th from the back side of the building have concrete crumbling with large holes that should be cleaned and patched.
