These are the findings of an inspection of your facility on the date(s) indicated above:

**A. Standards of Care**

- 1. Shelter is structurally sound Yes  
*While the building is structurally sound there are many kennels that are not. See note under "repairs done when necessary". The framework around the doors mentioned would allow for potential harm to a dog or possible escape.*
- 2. Housing area and equipment is sanitized regularly Yes  
*Evidence of rodents throughout the kennel area.*
- 3. Repairs are done when necessary No  
*Many kennels throughout the facility (2nd room in and also main kennel area) have screws protruding into the dog's living area. Many kennels in the main kennel room have broken framework around the doors. I also noted that kennel #11 had paint peeling off from the wall. One large kennel in the isolation area has walls that are torn apart with sharp edges. This kennel is currently not in use.*
- 4. Dogs are handled safely Yes
- 5. Adequate space is available for all dogs Yes
- 6. Light is sufficient for observation Yes
- 7. Ventilation is adequate Yes
- 8. Temperature extremes are avoided Yes
- 9. Clean food and water is available and in ample amount Yes
- 10. Veterinary care is provided when necessary Yes
- 11. Dogs are euthanized humanely, by authorized personnel Yes
