REMARKS:

The following municipalities DCO's have after hour access to the shelter and as per the contract may bring the dogs immediately after seizure. Broome, Carlisle, Cobleskill, Fulton, Jefferson and Middleburgh. The other municipalities maintain their own shelter and bring the dogs to ASSV as space allows.

The shelter has been collecting a \$25.00 impound fee from owners redeeming dogs. It is unknown if this amount is stated in each towns dog law or some other wordage that would allow this. Advised the shelter to contact the towns to find out if they have a set impound fee or they must charge only the statutory fee outlined in Article 7, Sec 117.4 (a, b, c) and 117.5.
