REMARKS:

According to Article 7 section 117.4 Dog Control, municipal shelters and municipalities may not waive Impoundment fees or charge less than the statutory rates for impoundment fees unless a local ordinance has been written. There were 2 dogs redeemed by the same owner for the town of Macomb. Both dogs were charged a \$15 impoundment fee. Assuming this was the owners first offense in 12 months dog #1 would have been your municipalities rate of \$15 (this was ok because it is not less than \$10 for the first offense) Dog #2 is any dog owned by that person was also charged your municipalities rate of \$15 (this was not the proper fee because it was less than the Statutory rate of \$20 for the 2nd offense). This also happened for 2 dogs owned by the same person for the town of LeRay which said there was a \$15 fee for a rabies vaccination for each dog then \$10/day for boarding which was explained to me for Dan' Moyer's boarding fee. this would be ok except there was no impoundment fee collected (which is for the town to retain) just boarding and rabies fees.

Statutory rates for Impoundment fees are as follows and may not be less than \$10 for the first impoundment, \$20 for the 2nd and first 24 hours, then +\$3 per day or \$30 for 3rd and first 24 hours, then +\$3 per day, unless there is a written local ordinance stating a specific circumstance. Such as: All impound fees shall be waived for all dogs who are seized under Article 7 and the owner is found and the rabies and license is up to date and provided within 1 hour of seizure. If your municipality chooses to make the fees higher no local ordinance is necessary. Just state it in the monthly board meeting minutes.

These fees/ count against the owner not the dog. Therefore, if an owner redeems his 2 dogs that would be considered a first and a second offense.
