REMARKS:

This inspection was conducted due to complaints received in the Albany office.

An inspection of the physical shelter and all record keeping was conducted. Records are kept in hard copy as well as entered into Pet Point software. All were made available for inspection.

Regarding REDEEMED DOGS ARE LICENSED BEFORE RELEASE:

- No license number was on file for a Terrier Mix seized in Niagara Falls on 4-15-19. (The dog was from Rochester but going to Florida.)
- No license number was on file for a German Shepherd seized in Niagara Falls on 6-28-19. (The owner resided in Florida.)
- No license number was on file for a dog seized in Niagara Falls. (The owner lived in Canada)
- No license number was on file for an Aussie Mix seized in the City of Lockport on 8-18-19. (The dog was three months old.)

REFERENCE: Please refer to Article 7 of New York State Agriculture and Markets Law for clarification on the licensing of dogs:

- Licensing of dogs owned by non-residents of NYS: Section 117.9 of Article 7 provides that seized dogs can be released to the owner upon proof the dog is licensed pursuant to the provisions of the law of the area of the owner's residence. If the owner is not in compliance with those provisions, the dog must be licensed with NYS as provided for in Section 117.6.

- Licensing of dogs under four months of age: Section 117.4 of Article 7 requires proof of licensing for any unidentified dog. This includes dogs of any age, regardless that they may be too young to receive a rabies vaccination.

- Acceptable licensing exemptions are listed in Section 107 of Article 7.

NOTE: The physical inspection of the facility began at approximately 1 pm. A moderate odor of stale animal wastes was detected in the adoptable dog kennel area. The same odors were also noticeable in the stray dog kennel area, but less so. The odors were then detectable in the lobby upon leaving the facility at approximately 4 pm. The odors were not of any strength that would cause a health issue to animals housed in the areas.
