REMARKS:

The shelter is severely overcrowded. This has not changed since the last inspection.

Two litters of pups and three dogs were infected with parvovirus after a pup came into the shelter that was sick and died (pit bull pup on3/27/11). A litter mate ("Huey") of the pup hat died was picked up the next day (3/28/11). This pup was brought to the shelter and became sick. The pup was brought to a veterinarian (Dr. Seaman). The pup was diagnosed with parvovirus and was euthanized. A newly arrived pup, "Sydney", was at the shelter for two days and hadn't yet been vaccinated. Yet, she was allowed to roam the building during a board meeting on 4/11/11. She became sick two days later and died overnight on 4/15/11.

4/14/11: Two more dogs (Duffy and Otto) died, presumably from parvovirus also.

4/17/11: Dooley (dog) and Ember (pup) became ill with signs of parvovirus. They responded to treatment and lived.

4/21/11: A pup from another litter was adopted out; that pup was diagnosed with parvovirus. Two more pups from that litter are sick today (the day of my visit).

The shelter is presently "closed" in an effort to prevent the further spread of parvovirus throughout the shelter. The sick pups are still being treated and the rest of the litter is considered exposed to the disease. They are in an "isolation ward", but despite the best efforts of the staff, there is still a risk of infecting other dogs in the kennel.

There is presently no room for any more dogs in the shelter. Even the garage, which is used as temporary housing with crates if the runs are full, is completely full with dogs and items that are going to be sold at a yard sale. There is "clutter" all over the shelter. Storage areas are being used to house dogs. Supplies, other necessary materials and food are not organized at all. In fact, the extreme clutter may be considered a fire hazard.

While I was there, a lost dog was brought into the shelter. It was placed in a cage in the entrance hall. It happened to be adjacent to a cat that was being housed in the same area.

It is recommended that more stringent biosecurity measures be put into place to prevent the further spread of any infectious diseases. The overcrowded shelter increases the stress on the animals and they are more likely to be susceptible to infectious diseases. Bacteria and viruses can also spread more easily when the animals are in such close proximity and scattered amongst the various rooms in the shelter.
