**For all seized dogs a disposition report must be filled out and an impoundment fee collected. All impoundment fees collected must be recorded with the disposition record. The disposition records are then reviewed at the time of inspection to determine compliance.**

**According to Article 7, section 117.4, any municipality may not waive fees or charge less than the statutory rates for impoundment fees unless a local ordinance has been written.**

**Section 117.4 gives the ability for a local ordinance to be written that enables the municipality to waive fees or charge fees that are more or less than the amounts prescribed in this same section of Article 7.**
