## REMARKS:

**D-155-21, D-178-21, D-004-22 and D-005-22 were released without impoundment fees being paid.**

**According to Article 7 section 117.4, Dog Control, municipal shelters and municipalities may not charge less than the statutory rates for impoundment fees unless a local ordinance has been written. For all dogs which are seized (picked up) up for Article 7 reasons, a disposition report must be filled out and an impoundment fee collected before returning the dog to the owner. All impoundment fees collected must be recorded with the disposition reports in order to determine this at the time of inspection. The shelter cannot release an "Article 7" dog unless the owner shows proof of current license, identification and proof that the impoundment fee has been paid. According to Article 7 Section 113.4 and 113.5, all records must reflect this information has been verified and be included in the disposition report.**
