Although there was ventilation in the dog kennel areas, the two rooms were wet and damp the day of inspection. The kennel rooms have cinder block walls and the dog runs are also constructed of cinder block. The housing areas had been hosed down an hour prior to the inspection but the floor and cinder block was still noticeably wet and damp. There is one ceiling fan and cold air vent in each kennel area. An overhead radiant heat system was not in use at this time. The days' weather was cool and rainy, which contributed to the dampness.

Applying sealant to the cinder block would make it impervious to liquids. A fan that creates more air movement would allow for quicker drying time. Heat from the radiant heat system would also decrease the water and dampness in the rooms. The fan and vent in ward one need to be cleaned as there was a buildup of dirt. Those improvements would decrease wet and damp conditions that can occur on high humidity days.
