## REMARKS:

Per Julie Lotter, repairs to kennels on south-facing side of building (towards pond) will begin on 3/9/23.

A written contract or lease agreement for shelter services for the Towns of Carrollton, Ellicottville and Freedom have not been provided for 2023.

According to Article 7 Section 114. Pounds and shelters,

1. Each town and city, and each village in which licenses are issued shall, and any other village and any county may, establish and maintain a pound or shelter for dogs.

2. In lieu of or in addition to establishing and maintaining such pound or shelter, any town or city, or any village in which licenses are issued shall, and any other village and any county may, contract for pound or shelter services with any other municipality or with any incorporated humane society or similar incorporated dog protective association, or shall establish and maintain, jointly or with one or more other municipalities, a pound or shelter.

The disposition of the male German Wirehaired Pointer seized 2/10/23 was incomplete. According to Article 7, Section 113.4 and 113.5, all records must be complete, including the disposition (what happened to the dog). According to Article 7, Sections 117.4, 117.6, and 117.9, all dogs being redeemed by their owners must be licensed before being released or if already licensed, the owner must show proof of current license. This information must be documented in the disposition record (the license number, name of the person/clerk/town who issued the license and the date the dog was redeemed).
