1. GENERAL PROGRAM INFORMATION

1.1 Program Description

The Department is seeking proposals for projects that will enhance the competitiveness of specialty crops in New York State. Funding for this RFP will be provided pursuant to the USDA Specialty Crop Block Grant Program – Farm Bill (SCBGP-FB), which is authorized under the Federal Specialty Crops Competitiveness Act of 2004, amended under section 10109 of the Food, Conservation, and Energy Act of 2008 (Farm Bill). The SCBGP-FB provides funding to State departments of agriculture solely to enhance the competitiveness of specialty crops. The Department is required to submit an application to USDA's Agriculture Marketing Service to receive funding, which is based on the proportion of the value of the State's specialty crop production in relation to the national value of specialty crop production. Projects selected pursuant to this RFP will be included in the Department's application to the USDA.

1.2 Program Purpose

New York's specialty crop agricultural and food systems industry is a valuable component of our State's economy, the environment, residents' health and quality of life. The purpose of New York's Specialty Crop Block Grant Program is to enhance the competitiveness of New York specialty crops by creating partnerships; fostering innovation; increasing efficiencies and reducing costs; promoting and developing new/existing markets; reaching consumers in rural, suburban and urban communities; and ensuring the long term viability of New York's specialty crop agricultural businesses and food systems.

1.3 Definition of Specialty Crops

For the purpose of this RFP, "specialty crops" means fruits and vegetables, tree nuts, dried fruits, and nursery crops (including floriculture). A detailed list of commonly recognized specialty crops is provided at www.ams.usda.gov/scbgp.

1.4 Available Funding

There is a total of \$900,000 available through this RFP.

2. ELIGIBILITY

2.1 Applicant Eligibility

Eligible applicants include:

- Not-for-profit organizations;
- State, local, and Indian tribal governments;

- For-profit organizations and individuals; and
- Educational institutions.

<u>NOTE:</u> Grant funds will not be awarded for projects that solely benefit a particular commercial product or provide a profit to a single organization, institution or individual. Single organizations, institutions and individuals are encouraged to participate as project partners.

Example of an **UNACCEPTABLE** project:

A grower requests grant funds to purchase starter plants or equipment to plant, cultivate and grow a specialty crop for the purpose of making a profit.

Example of an ACCEPTABLE project:

A grower requests funds to demonstrate the viability of organic small fruit production and partners with Cornell Cooperative Extension to publicize the findings and develop a working model for other regional growers.

2.2 Project Eligibility

The Department is soliciting proposals that *solely enhance the competitiveness of specialty crops* by addressing issues affecting the specialty crop industry as described in the funding categories set forth below. Proposals must fit within at least one of the specified funding categories. Applicants may submit proposals that fit within multiple categories, but <u>no more than three categories</u> should be addressed in a single proposal. Applicants may submit multiple proposals; however each proposal must be submitted separately.

1. Buy Local Packaging/Labeling

The ability of consumers to identify New York specialty crops is critical to realizing the full potential of the buy local movement and capturing the enormous purchasing power of over 19 million New York consumers. Effective packaging not only protects products, but can also help to communicate and promote a competitive image and increase sales. Examples of buy local packaging/labeling projects include but <u>are not limited to</u>:

- research, design and development of clever and distinct packaging and/or labeling to appeal to buy local interests;
- adding health, nutrient, farm practices or other brand development related information on packaging/labels;
- design and production of boxes, cartons, labels and other packaging that assists wholesalers, distributors, retailers and other partners throughout the distribution chain identify New York products;
- implementation of bar-codes/UPC scanning technology;

• establishing marketing clubs or other farmer-to-farmer cooperative arrangements that address packaging and labeling opportunities.

2. Conservation and Environmental Quality

Agriculture has a fundamental relationship with protecting New York's natural resources and enhancing the State's environmental quality. New York farmers and support organizations are undertaking many innovative practices and investing in a variety of technologies and methods to continually improve their environmental performance. Examples of conservation and environmental quality projects include but are not limited to:

- assisting communities and/or decision makers in planning for and protecting specialty crop agriculture;
- organic research focusing on conservation and sustainable agriculture outcomes;
- helping growers implement best management practices and/or resource-saving technologies to improve stewardship of soil, water, air and biodiversity;
- assisting New York specialty crop growers with regulatory challenges.

3. Distribution

Relatively few specialty crop businesses have the time, money or expertise to deliver their farm products themselves directly to customers. Yet distribution is a critical factor in ensuring that consumers receive the safest, most nutritious, highest quality products possible. Examples of distribution projects include but <u>are not limited to</u>:

- improving efficiency and reducing costs of processing and distribution infrastructure and systems;
- developing new approaches and innovative public/private partnerships between specialty crop producers, processors and intermediaries throughout the distribution chain (brokers, agents, distributors, wholesalers, retailers);
- assisting producers or producer groups in identifying traditional or more entrepreneurial methods to transport, process, aggregate, store, distribute and place their products or services.

4. Education and Outreach

Education and outreach are key to helping improve the public's awareness, knowledge and understanding of specialty crop agriculture and its value to the health and well being of all New Yorkers. Educational projects typically involve formal classroom settings for K-12 and college students, while outreach projects are generally designed to generate wider public

interest through short-term contact that informs and peeks interest. Examples of education and outreach projects include but <u>are not limited to</u>:

- development of traditional and non-traditional curriculum/ resources;
- providing professional development and training for educators;
- strengthening agricultural career technical education by improving access to job training skills;
- extending science-based information to growers, community leaders and other stakeholders;
- informing and motivating consumers about the economic, recreational, aesthetic, and environmental contributions that specialty crop agriculture makes to New Yorkers through events, media and other outreach tools.

5. Food Safety

Recent outbreaks of food borne illness linked to specialty crops have intensified both growers' and consumers' concerns about food safety. Growers and handlers are embracing voluntary Good Agricultural Practices (GAP) and Good Handling Practices (GHP) standards to minimize the threats of microbial contamination in the production of fresh fruits and vegetables. At the same time, processors of specialty crops take many precautions and follow industry and government standards through Good Manufacturing Processes (GMP). Maintaining food safety is paramount to the well-being of New Yorkers and is critical to maintaining consumer confidence of New York's specialty crop products. Examples of food safety focused projects include but are not limited to:

- research and extension leading to the production and manufacture of safe, high quality fruit, vegetable and other fresh and/or valueadded specialty crop products;
- education, promotion or implementation of Hazard Analysis Critical Control Point (HACCP) systems or other preventative food safety controls;
- assisting producers and processors in developing individual food safety plans and meeting food safety standards.
- consumer education about proper handling and preparation of raw specialty crop commodities that are not "ready to eat" (i.e. thorough washing, peeling, etc.)

6. Food Security

Unfortunately, not all New Yorkers have access to a sufficient supply of nutritious foods to meet their dietary needs on a regular basis. This lack of access has a variety of negative consequences upon individuals, families and even communities. Ensuring access to healthy foods, particularly in underserved low-income areas of the State, is a key strategy to improving public health and reducing health care costs. Examples of food security focused projects include but <u>are not limited to</u>:

- improving access to affordable, nutritious foods;
- developing community gardens and/or urban farms;
- increasing participation in under-utilized federal nutrition assistance programs.

7. Marketing and Promotion

New York State produces a wide range of specialty crops that rank highly in the nation in terms of production and economic value. The State's climate, fertile soils, abundant freshwater resources and innovative farmers offer New York the opportunity to produce and market a variety of high quality products locally, regionally and nationally. The seasonality of the State's production; however, can at times be a competitive disadvantage as New York producers compete with other areas of the country or the world that can supply fresh produce year-round. In this funding category, the Department will consider projects that increase the long-term sales and competitiveness of New York's specialty crop producers. In cases of otherwise comparable proposals, those involving Pride of New York will be favored. Examples of marketing and promotion focused projects include but <u>are not limited to</u>:

- increasing consumer awareness of the availability of fresh, frozen and processed New York State specialty crops;
- promoting preference for and helping consumers identify New York State specialty crop products in retail stores, restaurants and institutional outlets;
- supporting state-wide and regional cooperative marketing efforts, demonstrations, advertising and cross-promotions;
- increasing customers and sales of New York specialty crops at Farmers' Markets, Community Supported Agriculture (CSA) operations, produce auctions, roadside stands and other community and direct marketing outlets.

8. Nutrition

Increasing New Yorkers' access to and consumption of fruits, vegetables and tree nuts is a key strategy to improve human health and prevent chronic disease. The health benefits of increased specialty crop consumption are extensive and well documented. Examples of nutrition focused projects include but are not limited to:

farm-to-school initiatives:

- promoting and/or demonstrating the health benefits of New York specialty crops;
- developing public/private farm-to-table networks;
- increasing consumption of specialty crops among targeted ethnic populations;
- research leading to development of New York specialty crop products with increased health benefits.

9. Plant Health, Pest and Productivity Challenges

Protecting New York's specialty crops from the costly spread of invasive pests and disease is crucial to ensuring the productivity of New York's agricultural lands. Invasive species include noxious weeds, insect and vertebrate pests and plant diseases. Losses caused by pests and diseases cost New York's specialty crop industry millions of dollars annually. Pest/disease prevention and management programs that protect New York's food and agricultural crops from extensive damage in environmentally and cost-effective ways are essential to the future of the industry. Surveillance for the early detection of exotic plant pests is an essential element in safeguarding our agricultural resources. Examples of projects focusing on plant health, pest and productivity challenges include but are not limited to:

- developing and increasing the utilization of Integrated Pest Management strategies and programs;
- prioritizing and addressing native and exotic pest and disease threats through development of pest risk assessments;
- developing new seed varieties and specialty crops with optimal performance under New York State conditions;
- supporting plant breeding for the development of specialty crops resistant to exotic and native pests;
- research and extension that address a key conventional or organic production problem or need specific to New York State;
- applied research and development to extend the growing season of New York specialty crops through new technologies, improved management practices or other innovative production strategies.

10. Product Development

The development of new and innovative products that address consumer needs and/or trends can provide a significant advantage in capturing an increased portion of the market share. Examples of product development projects include but <u>are not limited to</u>:

 market research, analysis and development of new value-added products, product services or product lines;

- research and development of new specialty crop varieties that will provide New York producers an opportunity to remain competitive or gain a competitive advantage;
- assisting specialty crop producers and processors in developing product development strategies and commercialization plans.

11. International Trade Enhancement

New York's specialty crops products are sought after and found in markets throughout the world. Consumers in U.S. export markets are increasingly demanding high quality value-added food products as their disposable income rises. To capture these economic growth opportunities, the Department will consider projects that enhance the international trade marketing and trade of New York's specialty crops. Examples of international trade enhancement projects include but are not limited to:

- promoting export training and development with an emphasis on small, medium and/or new enterprises;
- supporting innovative consumer/trade promotions in foreign markets;
- advancing public/private trade partnerships in the international marketing of New York's specialty crops;
- identifying and proposing solutions that address international consumer perception barriers;
- developing resourceful solutions to transportation, storage and logistics barriers to delivering New York specialty crop products to international markets.

2.3 Project Duration

Projects must be completed within three years.

3. PROJECT COSTS

3.1 Eligible Costs

All costs must be directly associated with project activities that solely enhance the competitiveness of specialty crops. The use of grant funds awarded pursuant to this RFP is subject to the Federal Cost Principles applicable to the particular organization/entity that is receiving the funds. Applicants should refer to the applicable Cost Principles when developing their project activities and budget. To locate the principles applied in establishing the allowability or unallowability of specific items of cost, refer to the List of Selected Items of Cost Contained in OMB Cost Principles Regulations at http://www.ams.usda.gov/AMSv1.0/getfile?dDocName=STELPRDC5075580.

3.2 Ineligible Costs

Grant funds may NOT be used for the following:

- Activities that support non-specialty crops (See www.ams.usda.gov/AMSv1.0/scbgp for a list of commodities that are not considered specialty crops);
- Political activities:
- Lobbying activities;
- Capital expenditures for *general purpose* equipment, buildings and land.

General purpose equipment means equipment that is not limited to research, scientific or other technical activities. Examples include, but are not limited to, office equipment and furnishings, motor vehicles, etc.

4. PROPOSAL FORMAT

4.1 Application Form Instructions

Submit proposals using the 2009 New York Specialty Crop Block Grant Application Form.

General Instructions for Completing the Application Form

- 1. Provide all the information in the requested format. Failure to do so may result in a reduced rating or disqualification of a proposal.
- 2. Part B Project Details must be **no more than 4 pages**, not including letters of support. The acceptable font size is 12 pitch and all margins must be 1 inch.
- 3. Part C Budget Information must be **no more than 2 pages.** Use the format provided. Acceptable font size is 12 pitch.
- 4. Type all information if possible. Handwritten applications should be clearly legible.
- 5. Identify all pages of the Application in numerical order.
- 6. Staple each copy of the proposal in the upper left hand corner of the Application. *Do not use binders, folders, report covers, etc.*
- 7. Attach all required attachments, drawings, photos, support letters, etc. at the end of the Application Form.

The Department and State Comptroller's Office reserve the right to audit the applicant's books and records relating to the performance of the project during and up to six years after the completion of the project.

4.2 Checklist for Proposal Eligibility and Completeness (See Application Form)

Complete and sign the checklist and submit it with your application to ensure that your proposal is eligible to be considered for funding.

5. FUNDING CRITERIA

The Department's intent is to fund projects that produce the highest degree of public benefit and measurable outcomes to New York specialty crop producers in relation to each dollar spent. Proposals will be evaluated based on the criteria set forth in attached Rating Sheet. (See Attachment 1)

6. NYS OFFICE OF PARKS, RECREATION AND HISTORIC PRESERVATION REQUIREMENTS

Projects which include ground disturbing activities, construction of new buildings, or modification of buildings over 50 years old will be subject to further review by the NYS Office of Parks, Recreation and Historic Preservation (OPRHP). The Department reserves the right to request such additional information as is necessary to allow OPRHP to make a determination regarding the potential impacts of the project on historical sites or artifacts and possible alternatives which avoid or mitigate adverse impacts.

7. NYS ENVIRONMENTAL QUALITY REVIEW ACT REQUIREMENTS

Some projects may be subject to review under the New York State Environmental Quality Review Act (SEQRA). The Department reserves the right to request additional information as needed to comply with SEQRA requirements.

8. AWARD PROCESS

The Department will first screen applications to ensure that they meet the eligibility requirements. All proposals deemed eligible by the Department will be reviewed by the Specialty Crop Advisory Committee for technical comments. Proposals will then be evaluated by a Department panel according to the criteria stated in the attached Rating Sheet and ranked in order from highest to lowest. Those proposals receiving the highest numerical scores above the threshold score, continuing until available funds are exhausted, or until all proposals are funded, whichever occurs first, will be included in the Department's application to the USDA for SCBGP-FB funds. Awards of a minimum of \$30,000 up to a maximum of \$200,000 will be made upon of approval of the Department's application by the USDA.

The Department will send written notice to each applicant of its funding decisions. A contract defining all terms and conditions and responsibilities of the successful applicant shall be developed by the Department subsequent to the awarding of funds. The contract will incorporate the project description, plan of work form, and a budget approved by the Department, among its provisions. A copy of the standard clauses that set forth the general terms and conditions required in all contracts awarded by the Department under this program is attached to this RFP as Attachment 2.

Upon agreement by the contractor and the Department to the provisions of the contract, it will be submitted for approval to the Attorney General of the State of New York and the Comptroller of the State of New York. Grant funds will be disbursed on a reimbursement basis only after the contract is fully executed, *i.e.*, has been signed by all involved parties.

Review of Unsuccessful Applications

Upon request, the Department will advise any unsuccessful applicant as to the reasons that the proposal submitted was not selected for an award. A review should be requested by an unsuccessful applicant within thirty (30) days of the date of the notice that its proposal was not selected for an award.

9. REPORTING REQUIREMENTS

The Department of Agriculture and Markets will monitor contract performance. Annual progress reports that summarize the work completed on the project must be submitted within forty-five (45) days of the end of each year of the contract. All reports must conform to the Annual Performance Report Requirements set forth in Attachment 3. The Department reserves the right to modify reporting requirements during the course of the project. A final report will be required within forty-five (45) days following completion of the project. The final report must conform to the Final Performance Report Requirements set forth in Attachment 4. The final report will be included in the Department's final report that is submitted to USDA, which will be posted on the SCBG-FB website. The Department reserves the right to conduct a follow-up survey of funded projects in order to determine long-term impacts.

10. LIABILITY

The Department shall not be held liable for any costs incurred by any party for work performed in the preparation of and production of a proposal or for any work performed prior to the formal execution of a contract.

11. WORKERS' COMPENSATION AND DISABILITY INSURANCE REQUIREMENTS

New York State Workers' Compensation Law sections 57 and 220 require that the Department not enter into a contract unless proof of Workers' Compensation and Disability Insurance in a form satisfactory to the New York State Workers' Compensation Board has been secured.

Recipients of grants under this RFP will be required to produce proof of Workers' Compensation and Disability Insurance in a form satisfactory to the New York State Workers' Compensation Board prior to the execution of the contract.

Please refer to the Workers' Compensation and Disability Insurance Requirements posted on the Department's website, www.agmkt.state.ny.us under the heading of this RFP or visit the New York State Workers' Compensation Board website, www.wcb.state.nys.us for more information. You may contact the Board's Bureau of Compliance with any questions related to workers' compensation or disability insurance at (866) 298-7830.

12. OTHER CONSIDERATIONS

The Department reserves the right to:

- reject any or all proposals received with respect to this RFP;
- waive or modify minor irregularities in proposals received after prior notification and concurrence of the applicant;
- utilize any or all ideas submitted in the proposals received unless those ideas are covered by legal patent or proprietary rights;
- request from an applicant additional information as deemed necessary to more fully evaluate its proposal;
- amend the program's specifications after their release, with appropriate written notice posted on the Department's website;
- select only certain portions of proposals for funding;
- make all final decisions with respect to the amount of funding and the timing of payments to be provided to an applicant; and
- negotiate the terms of the budget.

All proposals submitted in response to this RFP will become the property of the New York State Department of Agriculture and Markets.

13. FREEDOM OF INFORMATION

All proposals submitted and all related contracts and reports may be subject to disclosure under the Freedom of Information Law.

14. APPENDIX A -- Standard Clauses for All State Contracts

Appendix A, which is attached to this RFP as Attachment 5, contains standard clauses which are required in all State contracts. Appendix A will be a part of any contract awarded under the 2009 Specialty Crop Block Grant Program and successful applicants will be responsible for complying with the terms and conditions contained therein.

15. FEDERAL CONDITIONS

Funds for this program will be provided to the Department pursuant to an agreement with the United States Department of Agriculture, Agricultural Marketing Service. Successful applicants will be required to comply with all applicable Federal statutes, regulations and policy requirements. GENERAL CONTRACT TERMS AND CONDITIONS

GENERAL CONDITIONS FOR AGREEMENTS

NEW YORK STATE DEPARTMENT OF AGRICULTURE AND MARKETS

These general conditions apply to the administrative aspects of the agreement and reflect New York State's contract record keeping and payment procedures. These general conditions cannot be changed.

PAYMENT

Payment shall be made to the **Contractor** under this Agreement upon the submission of a payment request (standard voucher), the required progress report and a budget report in the format prescribed by the **Department**.

The **Contractor** shall submit all requests for payment and reports to the following address: NYS Department of Agriculture and Markets, Division of Fiscal Management, 10B Airline Drive, Albany, NY 12235. Invoices, Standard Vouchers and any reports will not be considered received by the **Department** and any interest which may be due the **Contractor** will not begin to accrue until they have been received by the Division of Fiscal Management.

Initial payment to the **Contractor** under this Agreement shall not be made unless the **Contractor** shall have submitted to the **Department** a written payment request together with such information as required by the Agreement. Initial payment shall not be due until the latter of either the last day of the calendar month of the term of this Agreement, or the thirtieth calendar day after receipt of the payment request, where contract funds have been appropriated and made available to the **Department**.

Payments shall not be made if the **Contractor** fails to file the progress reports and budget reports, if any, as required by this Agreement. The **Contractor's** payment requests shall include a statement of expenses and charges by major budget category for work actually performed or expenses incurred in accordance with the terms of this Agreement during the period covered by the request.

Upon examination of the **Contractor's** payment requests and supporting material, the **Department** may, in its sole discretion, modify or adjust the amount requested to reflect contract funds expended as of the date of the request. Subsequent to its review and approval of the payment request, the **Department** will transmit the request to the Comptroller for payment.

The total payment made under this Agreement will not exceed the **Contractor's** actual costs and expenses arising from the completion of the work under this

Agreement.

Final payment, including payment of retained amounts if any, shall not be made until work under the Agreement is completed to the satisfaction of the **Department** and the **Contractor's** final performance report and a final budget report detailing receipt and expenditure of all funds received pursuant to this Agreement by major budget category are received and accepted by the **Department**. Satisfactory completion and acceptance shall be defined as conformance to established standards for such reports and conformance to the attached plan of work.

PROGRESS REPORTS

The **Contractor** shall file written progress reports with the **Department** within forty-five (45) days of the end of each year of this Agreement. Progress reports shall be in a format specified by the Department.

PAYMENT CONTINGENCY

Funds for payment under this Agreement are provided to the **Department** through appropriations from the New York State Legislature. These appropriations are made on a fiscal year basis. New York State's fiscal year begins on April 1 of each calendar year and ends on March 31 of the following calendar year. Funds for payments under this Agreement were or are expected to be appropriated to the **Department** during fiscal year **2009-2010**. Payments made after fiscal year **2009-2010** or payment for work pursuant to this Agreement which is completed or continued by the **Contractor** after fiscal year **2009-2010** is subject to appropriation of funds by the Legislature in each subsequent fiscal year.

RETAINAGE

The **Department** shall retain ten (10) percent of the budget amount of this Agreement once payment to the **Contractor** equals ninety (90) percent of the budget amount to ensure completion of the work under this Agreement. The total amount retained shall be paid to the **Contractor** together with the final payment under this Agreement and shall be subject to the same conditions as the final payment.

FINANCIAL LIMIT

The financial limit of State appropriated funds under this Agreement shall not exceed the amount indicated on the latest executed version of the signature page of this Agreement and the **Department** shall not be obligated to make any payment to the **Contractor** in excess of that amount.

CONTRACT EXPENDITURES

Expenditures under this Agreement shall conform to the budget annexed as Appendix B, provided however, that the **Contractor** may vary budget amounts by not more than ten percent (10%) within each specific budget category. Any budget variance in excess of ten percent (10%) shall be made only upon the prior written approval of the **Department**. This paragraph does not apply to budget amounts of one thousand dollars (\$1,000.00) or less.

NON-DUPLICATION OF PAYMENTS

The payments received by the **Contractor** under this Agreement shall not duplicate payments received from any other source for the work performed under this Agreement. In the event of such duplication, the **Contractor** shall remit to the **Department** the amount which duplicates payment received from other sources.

SUBCONTRACTS

Any subcontract under this Agreement shall be in writing and shall clearly describe the goods or services to be provided and the total cost of such goods or services. Subcontracts for services only shall separately state the rate of compensation on a per-hour or per-day basis.

FINAL REPORT

Not later than *forty-five (45)* days from the end date of this Agreement, the **Contractor** shall file with the **Department** a final written report in a format specified by the **Department**.

RECORDS MAINTENANCE, EXAMINATION AND RETENTION

The **Contractor** shall maintain records and accounts in specific detail to identify all contract funds received and expended under this Agreement. The **Contractor** shall maintain a daily written record which contains the name(s) of the officer(s) and employee(s) providing services under this Agreement and the amount of time expended upon such services.

The **Contractor** shall maintain the records required under this paragraph as set forth in Appendix A to this Agreement.

INDEMNIFICATION

The **Contractor** agrees to indemnify and hold harmless the State of New York and the **Department** from all liability incurred by the **Department** for bodily injury and personal property damage resulting from the negligent acts, errors or omissions of the

Contractor, its officers, agents or employees in the provision of services under this Agreement, provided that the **Department** promptly notify the **Contractor** of any such claim and afford the **Contractor** an opportunity to defend such claim and cooperate fully with the **Contractor** in the defense of any claims.

NON-SECTARIAN PURPOSE

The **Contractor** shall not expend funds received under this Agreement for any purposes other than for performance of the work under this Agreement, and hereby represents that no contract funds shall be expended directly or indirectly for any private or sectarian purpose.

CONTRACTOR NOT DEPARTMENT EMPLOYEE OR AGENT

Neither the **Contractor**, nor its agents, employees, suppliers or subcontractors shall be in any way deemed to be employees or agents of the **Department** or of the State of New York in performing the work under this Agreement.

DEVIATION FROM WORK

The **Contractor** shall perform the work under this Agreement as outlined in the scope of work annexed as Appendix C. Any substantial deviation from the plan of work shall require the prior written approval of the **Department**.

TERMINATION

The **Department** may terminate this Agreement for convenience upon giving thirty (30) days written notice to the **Contractor**. This Agreement may be terminated at any time upon mutual written consent of the **Department** and the **Contractor**. Upon termination, the **Contractor** shall immediately cease work and prepare a statement of costs, expenses and non-cancelable commitments incurred as of the date of such termination.

The **Department** may terminate this Agreement for cause upon giving one (1) days written notice.

The **Contractor's** failure to perform in accordance with the terms of this Agreement due to circumstances reasonably beyond the **Contractor's** control should not constitute cause for termination pursuant to this provision. In the event of such failure to perform, the **Department** may, at its option, either grant the **Contractor** a specified period in which to correct its performance, or terminate this Agreement in accordance with this paragraph.

MODIFICATION

This Agreement may not be modified unless such modification is made in writing, executed by the **Department** and the **Contractor** and approved by the Attorney General and Comptroller of the State of New York.

NECESSARY SIGNATURES

This Agreement shall not be binding and effective upon the **Department** unless and until approved by the Attorney General and the Comptroller of the State of New York.

SPECIAL CONDITIONS FOR AGREEMENTS

NEW YORK STATE DEPARTMENT OF AGRICULTURE AND MARKETS

These special conditions apply to the administrative aspects of this particular agreement. These special conditions cannot be changed.

ADVANCE PAYMENT (*Not-for-profit contractors only*)

An advance payment of not more than twenty-five percent (25%) of the amount to be paid under this Agreement may be made to the **Contractor** after approval of this Agreement by the State Comptroller.

AUDIT OF RECORDS

The **Contractor** agrees that the Comptroller General of the United States, or his duly authorized representative and accredited representatives of the United States Department of Agriculture or cognizant audit agency, shall, until the expiration of three years after final payment under this Agreement, have access to and the right to examine any directly pertinent books, documents, papers and records of the **Contractor**. These records must be maintained by the **Contractor** for that period of time.

INSURANCE

The **Contractor** shall obtain and keep in force during the term of this Agreement insurance policies, naming the State of New York and the **Department** as additional insured as follows:

STANDARD CLAUSES FOR NYS CONTRACTS

The parties to the attached contract, license, lease, amendment or other agreement of any kind (hereinafter, "the contract" or "this contract") agree to be bound by the following clauses which are hereby made a part of the contract (the word "Contractor" herein refers to any party other than the State, whether a contractor, licenser, licensee, lessor, lessee or any other party):

- 1. <u>EXECUTORY CLAUSE</u>. In accordance with Section 41 of the State Finance Law, the State shall have no liability under this contract to the Contractor or to anyone else beyond funds appropriated and available for this contract.
- 2. NON-ASSIGNMENT CLAUSE. In accordance with Section 138 of the State Finance Law, this contract may not be assigned by the Contractor or its right, title or interest therein assigned, transferred, conveyed, sublet or otherwise disposed of without the previous consent, in writing, of the State and any attempts to assign the contract without the State's written consent are null and void. The Contractor may, however, assign its right to receive payment without the State's prior written consent unless this contract concerns Certificates of Participation pursuant to Article 5-A of the State Finance Law.
- 3. COMPTROLLER'S APPROVAL. In accordance with Section 112 of the State Finance Law (or, if this contract is with the State University or City University of New York, Section 355 or Section 6218 of the Education Law), if this contract exceeds \$50,000 (or the minimum thresholds agreed to by the Office of the State Comptroller for certain S.U.N.Y. and C.U.N.Y. contracts), or if this is an amendment for any amount to a contract which, as so amended, exceeds said statutory amount, or if, by this contract, the State agrees to give something other than money when the value or reasonably estimated value of such consideration exceeds \$10,000, it shall not be valid, effective or binding upon the State until it has been approved by the State Comptroller and filed in his office. Comptroller's approval of contracts let by the Office of General Services is required when such contracts exceed \$85,000 (State Finance Law Section 163.6.a).
- **4. WORKERS' COMPENSATION BENEFITS.** In accordance with Section 142 of the State Finance Law, this contract shall be void and of no force and effect unless the Contractor shall provide and maintain coverage during the life of this contract for the benefit of such employees as are required to be covered by the provisions of the Workers' Compensation Law.
- 5. NON-DISCRIMINATION REQUIREMENTS. To the extent required by Article 15 of the Executive Law (also known as the Human Rights Law) and all other State and Federal statutory and constitutional non-discrimination provisions, the Contractor will not discriminate against any employee or applicant for employment because of race, creed, color, sex, national origin, sexual orientation, age, disability, genetic predisposition or carrier status, or marital status. Furthermore, in accordance with Section 220-e of the Labor Law, if this is a contract for the construction, alteration or repair of any public building or public work or for the manufacture, sale or distribution of materials, equipment or supplies, and to the extent that this contract shall be performed within the State of New York, Contractor agrees that neither it nor its subcontractors shall, by reason of race, creed, color, disability, sex, or national origin: (a) discriminate in hiring against any New York State citizen who is qualified and available to perform the work; or (b) discriminate against or intimidate any employee hired for the performance of work under this contract. If this is a building service contract as defined in Section 230 of the Labor

Law, then, in accordance with Section 239 thereof, Contractor agrees that neither it nor its subcontractors shall by reason of race, creed, color, national origin, age, sex or disability: (a) discriminate in hiring against any New York State citizen who is qualified and available to perform the work; or (b) discriminate against or intimidate any employee hired for the performance of work under this contract. Contractor is subject to fines of \$50.00 per person per day for any violation of Section 220-e or Section 239 as well as possible termination of this contract and forfeiture of all moneys due hereunder for a second or subsequent violation.

- 6. WAGE AND HOURS PROVISIONS. If this is a public work contract covered by Article 8 of the Labor Law or a building service contract covered by Article 9 thereof, neither Contractor's employees nor the employees of its subcontractors may be required or permitted to work more than the number of hours or days stated in said statutes, except as otherwise provided in the Labor Law and as set forth in prevailing wage and supplement schedules issued by the State Labor Department. Furthermore, Contractor and its subcontractors must pay at least the prevailing wage rate and pay or provide the prevailing supplements, including the premium rates for overtime pay, as determined by the State Labor Department in accordance with the Labor Law.
- 7. NON-COLLUSIVE BIDDING CERTIFICATION. In accordance with Section 139-d of the State Finance Law, if this contract was awarded based upon the submission of bids, Contractor affirms, under penalty of perjury, that its bid was arrived at independently and without collusion aimed at restricting competition. Contractor further affirms that, at the time Contractor submitted its bid, an authorized and responsible person executed and delivered to the State a non-collusive bidding certification on Contractor's behalf.
- 8. INTERNATIONAL BOYCOTT PROHIBITION. In accordance with Section 220-f of the Labor Law and Section 139-h of the State Finance Law, if this contract exceeds \$5,000, the Contractor agrees, as a material condition of the contract, that neither the Contractor nor any substantially owned or affiliated person, firm, partnership or corporation has participated, is participating, or shall participate in an international boycott in violation of the federal Export Administration Act of 1979 (50 USC App. Sections 2401 et seq.) or regulations thereunder. If such Contractor, or any of the aforesaid affiliates of Contractor, is convicted or is otherwise found to have violated said laws or regulations upon the final determination of the United States Commerce Department or any other appropriate agency of the United States subsequent to the contract's execution, such contract, amendment or modification thereto shall be rendered forfeit and void. Contractor shall so notify the State Comptroller within five (5) business days of such conviction, determination or disposition of appeal (2NYCRR 105.4).
- 9. <u>SET-OFF RIGHTS</u>. The State shall have all of its common law, equitable and statutory rights of set-off. These rights shall include, but not be limited to, the State's option to withhold for the purposes of set-off any moneys due to the Contractor under this contract up to any amounts due and owing to the State with regard to this contract, any other contract with any State department or agency, including any contract for a term commencing prior to the term of this contract, plus any amounts due and owing to the State for any other reason including, without limitation, tax delinquencies, fee delinquencies or monetary penalties relative thereto. The State shall exercise its set-off rights in accordance with normal State practices including, in cases of set-off pursuant to an audit, the finalization of such audit by the State agency, its representatives, or the State Comptroller.

10. RECORDS. The Contractor shall establish and maintain complete and accurate books, records, documents, accounts and other evidence directly pertinent to performance under this contract (hereinafter, collectively, "the Records"). The Records must be kept for the balance of the calendar year in which they were made and for six (6) additional years thereafter. The State Comptroller, the Attorney General and any other person or entity authorized to conduct an examination, as well as the agency or agencies involved in this contract, shall have access to the Records during normal business hours at an office of the Contractor within the State of New York or, if no such office is available, at a mutually agreeable and reasonable venue within the State, for the term specified above for the purposes of inspection, auditing and copying. The State shall take reasonable steps to protect from public disclosure any of the Records which are exempt from disclosure under Section 87 of the Public Officers Law (the "Statute") provided that: (i) the Contractor shall timely inform an appropriate State official, in writing, that said records should not be disclosed; and (ii) said records shall be sufficiently identified; and (iii) designation of said records as exempt under the Statute is reasonable. Nothing contained herein shall diminish, or in any way adversely affect, the State's right to discovery in any pending or future litigation.

- **IDENTIFYING** INFORMATION **AND PRIVACY** 11. NOTIFICATION. (a) FEDERAL EMPLOYER IDENTIFICATION NUMBER and/or FEDERAL SOCIAL SECURITY NUMBER. All invoices or New York State standard vouchers submitted for payment for the sale of goods or services or the lease of real or personal property to a New York State agency must include the payee's identification number, i.e., the seller's or lessor's identification number. The number is either the payee's Federal employer identification number or Federal social security number, or both such numbers when the payee has both such numbers. Failure to include this number or numbers may delay payment. Where the payee does not have such number or numbers, the payee, on its invoice or New York State standard voucher, must give the reason or reasons why the payee does not have such number or numbers.
- (b) PRIVACY NOTIFICATION. (1) The authority to request the above personal information from a seller of goods or services or a lessor of real or personal property, and the authority to maintain such information, is found in Section 5 of the State Tax Law. Disclosure of this information by the seller or lessor to the State is mandatory. - 12. EQUAL EMPLOYMENT OPPORTUNITIES FOR MINORITIES AND WOMEN. In accordance with Section 312 of the Executive Law, if this contract is: (i) a written agreement or purchase order instrument, providing for a total expenditure in excess of \$25,000.00, whereby a contracting agency is committed to expend or does expend funds in return for labor, services, supplies, equipment, materials or any combination of the

foregoing, to be performed for, or rendered or furnished to the contracting agency; or (ii) a written agreement in excess of \$100,000.00 whereby a contracting agency is committed to expend or does expend funds for the acquisition, construction, demolition, replacement, major repair or renovation of real property and improvements thereon; or (iii) a written agreement in excess of \$100,000.00 whereby the owner of a State assisted housing project is committed to expend or does expend funds for the acquisition, construction, demolition, replacement, major repair or renovation of real property and improvements thereon for such project, then:

Contractor will include the provisions of "a", "b", and "c" above, in every subcontract over \$25,000.00 for the construction, demolition, replacement, major repair, renovation, planning or design of real property and improvements thereon (the "Work") except where the Work is for the beneficial use of the Contractor. Section 312 does not apply to: (i) work, goods or services unrelated to this contract; or (ii) employment outside New York State; or (iii) banking services, insurance policies or the sale of securities. The State shall consider compliance by a contractor or subcontractor with the requirements of any federal law concerning equal employment opportunity which effectuates the purpose of this section. The contracting agency shall determine whether the imposition of the requirements of the provisions hereof duplicate or conflict with any such federal law and if such duplication or conflict exists, the contracting agency shall waive the applicability of Section 312 to the extent of such duplication or conflict. Contractor will comply with all duly promulgated and lawful rules and regulations of the Governor's Office of Minority and Women's Business Development pertaining hereto.

- **13. CONFLICTING TERMS.** In the event of a conflict between the terms of the contract (including any and all attachments thereto and amendments thereof) and the terms of this Appendix A, the terms of this Appendix A shall control.
- **14. GOVERNING LAW.** This contract shall be governed by the laws of the State of New York except where the Federal supremacy clause requires otherwise.

15. <u>LATE PAYMENT</u>. Timeliness of payment and any interest to be paid to Contractor for late payment shall be governed by Article 11-A of the State Finance Law to the extent required by law

- **16. NO ARBITRATION.** Disputes involving this contract, including the breach or alleged breach thereof, may not be submitted to binding arbitration (except where statutorily authorized), but must, instead, be heard in a court of competent jurisdiction of the State of New York.
- 17. SERVICE OF PROCESS. In addition to the methods of service allowed by the State Civil Practice Law & Rules ("CPLR"), Contractor hereby consents to service of process upon it by registered or certified mail, return receipt requested. Service hereunder shall be complete upon Contractor's actual receipt of process or upon the State's receipt of the return thereof by the United States Postal Service as refused or undeliverable. Contractor must promptly notify the State, in writing, of each and every change of address to which service of process can be made. Service by the State to the last known address shall be sufficient. Contractor will have thirty (30) calendar days after service hereunder is complete in which to respond.
- 18. PROHIBITION ON PURCHASE OF TROPICAL HARDWOODS. The Contractor certifies and warrants that all wood products to be used under this contract award will be in accordance with, but not limited to, the specifications and provisions of State Finance Law §165. (Use of Tropical Hardwoods) which prohibits purchase and use of tropical hardwoods, unless specifically exempted, by the State or any governmental agency or political subdivision or public benefit corporation. Qualification for an exemption under this law will be the responsibility of the contractor to establish to meet with the approval of the State.

In addition, when any portion of this contract involving the use of woods, whether supply or installation, is to be performed by any subcontractor, the prime Contractor will indicate and certify in the submitted bid proposal that the subcontractor has been informed and is in compliance with specifications and provisions regarding use of tropical hardwoods as detailed in §165 State Finance Law. Any such use must meet with the approval of the State; otherwise, the bid may not be considered responsive. Under bidder certifications, proof of qualification for exemption will be the responsibility of the Contractor to meet with the approval of the State.

- 19. MACBRIDE FAIR EMPLOYMENT PRINCIPLES. In accordance with the MacBride Fair Employment Principles (Chapter 807 of the Laws of 1992), the Contractor hereby stipulates that the Contractor either (a) has no business operations in Northern Ireland, or (b) shall take lawful steps in good faith to conduct any business operations in Northern Ireland in accordance with the MacBride Fair Employment Principles (as described in Section 165 of the New York State Finance Law), and shall permit independent monitoring of compliance with such principles.
- **20.** OMNIBUS PROCUREMENT ACT OF 1992. It is the policy of New York State to maximize opportunities for the participation of New York State business enterprises, including minority and women-owned business enterprises as bidders, subcontractors and suppliers on its procurement contracts.
