## **Questions and Answers and Amendment 1**

\*Please note that the questions that follow are taken directly from the emails received by the Department.

1. Hello, I have questions concerning the minimum bid on this procurement. Based on the 3900 square feet offered, and the published rates on the New York State Fair website of \$6.60 per square foot, the minimum bid required is \$2.10 per square foot higher than other straight sales vendors. Why is the mobility concession required to bid a higher square footage rate than other straight sales vendors? Are all other straight sales vendors required to bid based upon the previous years sales?

The New York State Fair's published 2017 concession and exhibit rates were revised on February 21, 2017. The minimum bid will be amended to \$1,653.46 per day (\$21,495 total for 13 days) in accordance with the revised rates calculated as follows (See Amendment 1 to IFB#0154 attached):

Bidder shall provide per unit rental prices to be charged to Fair Patrons for the rental of electric scooters, wheelchairs, strollers and wagons. Full day and half day rentals shall be available for rental of electric scooters. The hours for half day rentals are 7:00 a.m. to 3:00 p.m. or 3:00 p.m. to 11:00 p.m. NOTE: The per item rental prices bid shall remain firm for the Term of the Agreement subject to any price adjustment pursuant to Section 5.3 of the IFB.

Strike the last sentence in Section 4.2.1 "ITEM 1 ASSESSMENT - CONCESSION AND EXHIBIT LICENSE FEE (80%)" and replace with the following:
